

Cell-ebtrate Science Trivia Contest Rules and Regulations

Eligibility

- 1) Participation is open to people aged 21 years and above and residing in Singapore. Healthcare professionals and government officials may not participate in this competition. It is the responsibility of the program participant to determine his or her eligibility based on governing law and the policies and practices of his or her institution or employer or industry codes of conduct. Employees of Life Technologies Holdings Pte Ltd (“Thermo Fisher Scientific”) and its affiliates, as well as their family and household members, are not eligible to participate.
