SECTION 4. FIRST AID MEASURES

Eye Contact

Inhalation

Remove from exposure, lie down. Remove to fresh air. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Immediate medical attention is required. If not breathing, give artificial respiration.
