Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Keep away from oxidizing agents. Purge open drums with nitrogen before resealing. Should crystals form in a peroxidizable liquid, peroxidation may have occurred and the product should be considered extremely dangerous.
