# **SECTION 4. FIRST AID MEASURES**

#### **General Advice**

Show this safety data sheet to the doctor in attendance. Immediate medical attention is required.

#### Eye Contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Immediate medical attention is required.

#### Skin Contact

Wash off immediately with plenty of water for at least 15 minutes. Remove and wash contaminated clothing and gloves, including the inside, before re-use. Call a physician immediately.

#### Inhalation

If not breathing, give artificial respiration. Remove from exposure, lie down. ## Ingestion

### Most important symptoms and effects

## **Specific Hazards Arising from the Chemical**
