SECTION 4. FIRST AID MEASURES

Eye Contact

Inhalation

Remove to fresh air. Immediate medical attention is required. If not breathing, give artificial respiration.

Ingestion

Do NOT induce vomiting. Call a physician or poison control center immediately.
