#### **SECTION 4. FIRST AID MEASURES**

#### **General Advice**

#### Eye Contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. In the case of contact with eyes, rinse immediately with plenty of water and seek medical advice.

## Skin Contact

Wash off immediately with plenty of water for at least 15 minutes. Immediate medical attention is required.

#### Inhalation

If not breathing, give artificial respiration. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Remove to fresh air. Immediate medical attention is required.

#### Ingestion

Do NOT induce vomiting. Call a physician or poison control center immediately.

#### Most important symptoms and effects

Causes burns by all exposure routes. Symptoms of overexposure may be headache, dizziness, tiredness, nausea and vomiting: Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated: Ingestion causes severe swelling, severe damage to the delicate tissue and danger of perforation

#### Self-Protection of the First Aider

Ensure that medical personnel are aware of the material(s) involved, take precautions to protect themselves and prevent spread of contamination.

## **SECTION 5. FIRE-FIGHTING MEASURES**

#### Suitable Extinguishing Media

Carbon dioxide (CO<sub>2</sub>). Dry chemical. Water mist may be used to cool closed containers. Chemical foam. Water mist may be used to cool closed containers. CO<sub>2</sub>, dry chemical, dry sand, alcohol-resistant foam.

#### **Specific Hazards Arising from the Chemical**

#### **Protective Equipment and Precautions for Firefighters**

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear. Thermal decomposition can lead to release of irritating gases and vapors.

#### Methods for Containment and Clean Up

Keep in suitable, closed containers for disposal. Soak up with inert absorbent material. Do not expose spill to water. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.

#### Handling

If swallowed then seek immediate medical assistance. Do not allow contact with water. Keep away from open flames, hot surfaces and sources of ignition. Use only non-sparking tools. Take precautionary measures against static discharges.

#### Storage

Keep in a dry place. Keep container tightly closed. Keep away from heat, sparks and flame. Refrigerator/flammables. Keep containers tightly closed in a dry, cool and well-ventilated place. Corrosives area. Keep away from water or moist air.
