#### 3-Aminopyridine

### Eye Contact

Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes.

#### Skin Contact

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Immediate medical attention is required.

#### Inhalation

Remove from exposure, lie down. Remove to fresh air. If not breathing, give artificial respiration. Immediate medical attention is required.

#### Ingestion

Never give anything by mouth to an unconscious person. Drink plenty of water. Call a physician immediately. Clean mouth with water. If possible drink milk afterwards.
