SECTION 4. FIRST AID MEASURES

Eye Contact

SECTION 5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Carbon dioxide (CO₂). Dry chemical. Chemical foam. Do not use a solid water stream as it may scatter and spread fire. Water mist may be used to cool closed containers.
