SECTION 4. FIRST AID MEASURES

Eye Contact

SECTION 5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

CO₂, dry chemical, dry sand, alcohol-resistant foam. Water mist may be used to cool closed containers.

Extinguishing media which must not be used for safety reasons

Water may be ineffective.

Specific Hazards Arising from the Chemical

Flammable. Risk of ignition. Vapors may form explosive mixtures with air. Vapors may travel to source of ignition and flash back. Containers may explode when heated. Thermal decomposition can lead to release of irritating gases and vapors. Keep product and empty container away from heat and sources of ignition.

Protective Equipment and Precautions for Firefighters

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions

Use personal protective equipment as required. Remove all sources of ignition. Take precautionary measures against static discharges. Avoid contact with skin, eyes or clothing.

Environmental Precautions

Avoid release to the environment.

Methods for Containment and Clean Up

Remove all sources of ignition. Soak up with inert absorbent material. Keep in suitable, closed containers for disposal. Use spark-proof tools and explosion-proof equipment.

SECTION 7. HANDLING AND STORAGE

Handling

Avoid contact with skin and eyes. Do not breathe mist/vapors/spray. Do not ingest. If swallowed then seek immediate medical assistance. Use spark-proof tools and explosion-proof equipment. Use only non-sparking tools. Keep away from open flames, hot surfaces and sources of ignition. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Take precautionary measures against static discharges.

Keep in a dry, cool and well-ventilated place. Keep container tightly closed. Keep away from heat, sparks and flame. Flammables area. Keep container tightly closed in a dry and well-ventilated place.
