## SECTION 4. FIRST AID MEASURES

### **Eye Contact**

Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes.

#### **Skin Contact**

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Immediate medical attention is required.

#### Inhalation

Remove from exposure, lie down. Remove to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. Immediate medical attention is required.

#### Ingestion

Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Drink plenty of water. Call a physician immediately. Clean mouth with water. If possible drink milk afterwards.

#### Most important symptoms and effects

Difficulty in breathing. Causes burns by all exposure routes. Inhalation of high vapor concentrations may cause symptoms like headache, dizziness, tiredness, nausea and vomiting: Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated: Ingestion causes severe swelling, severe damage to the delicate tissue and danger of perforation

#### Self-Protection of the First Aider

## **SECTION 5. FIRE-FIGHTING MEASURES**

#### Handling
