#### **Environmental hazards**

Spillage unlikely to penetrate soil. The product is insoluble and sinks in water. The product contains volatile organic compounds (VOC) which will evaporate easily from all surfaces.

## SECTION 4. FIRST AID MEASURES

#### General Advice

#### Eye Contact

#### Most important symptoms and effects

Causes burns by all exposure routes. Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated: Ingestion causes severe swelling, severe damage to the delicate tissue and danger of perforation

#### Self-Protection of the First Aider

Ensure that medical personnel are aware of the material(s) involved, take precautions to protect themselves and prevent spread of contamination.

## **SECTION 5. FIRE-FIGHTING MEASURES**

#### Suitable Extinguishing Media

Carbon dioxide (CO<sub>2</sub>). Dry chemical. Chemical foam. CO<sub>2</sub>, dry chemical, dry sand, alcohol-resistant foam.

Water.

#### **Specific Hazards Arising from the Chemical**

Thermal decomposition can lead to release of irritating gases and vapors. The product causes burns of eyes, skin and mucous membranes.
