SECTION 4. FIRST AID MEASURES

Eye Contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Get medical attention.

Skin Contact

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Get medical attention.

Inhalation

Remove from exposure, lie down. Remove to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. Get medical attention.

Ingestion

Clean mouth with water. Get medical attention.

Most important symptoms and effects

2-Ethyl-1-hexanol

Difficulty in breathing. Symptoms of overexposure may be headache, dizziness, tiredness, nausea and vomiting

Self-Protection of the First Aider

Ensure that medical personnel are aware of the material(s) involved, take precautions to protect themselves and prevent spread of contamination.

Treat symptomatically. Symptoms may be delayed.

SECTION 5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Water spray. Carbon dioxide (CO 2). Dry chemical. Chemical foam. Water mist may be used to cool closed containers.

Methods for Containment and Clean Up

Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Keep in suitable, closed containers for disposal. Do not let this chemical enter the environment. Remove all sources of ignition. Take precautionary measures against static discharges.

Handling

Engineering Measures
