# **SECTION 4. FIRST AID MEASURES**

2,3,5-Collidine

## Eye Contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Get medical attention.

#### Inhalation

Remove from exposure, lie down. Remove to fresh air. If not breathing, give artificial respiration. Get medical attention.

#### Most important symptoms and effects

Difficulty in breathing. Symptoms of overexposure may be headache, dizziness, tiredness, nausea and vomiting

# **SECTION 5. FIRE-FIGHTING MEASURES**
