SECTION 4. FIRST AID MEASURES

General Advice

Most important symptoms and effects

Difficulty in breathing. Causes burns by all exposure routes. SECTION 5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

CO₂, dry chemical, dry sand, alcohol-resistant foam. Water mist may be used to cool closed containers.

Specific Hazards Arising from the Chemical
