SECTION 4. FIRST AID MEASURES

Eye Contact

SECTION 5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Keep in suitable, closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.

Handling

Take precautionary measures against static discharges. Wash hands before breaks and immediately after handling the product.
