## **SECTION 4. FIRST AID MEASURES**

### **General Advice**

#### Eye Contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Immediate medical attention is required.

#### Skin Contact

#### Inhalation

If not breathing, give artificial respiration. Remove from exposure, lie down. ### **SECTION 5. FIRE-FIGHTING MEASURES**

#### Suitable Extinguishing Media

#### **Specific Hazards Arising from the Chemical**
