SECTION 4. FIRST AID MEASURES

General Advice

SECTION 5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

CO₂, dry chemical, dry sand, alcohol-resistant foam. Water mist may be used to cool closed containers.

Extinguishing media which must not be used for safety reasons

Do not use a solid water stream as it may scatter and spread fire.

Specific Hazards Arising from the Chemical

Flammable. Keep product and empty container away from heat and sources of ignition. Thermal decomposition can lead to release of irritating gases and vapors. Containers may explode when heated. Vapors may form explosive mixtures with air. Vapors may travel to source of ignition and flash back.

Protective Equipment and Precautions for Firefighters

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear.
