SECTION 4. FIRST AID MEASURES

Eye Contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Get medical attention.

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Get medical attention.

Inhalation

Remove from exposure, lie down. Remove to fresh air. If not breathing, give artificial respiration. Get medical attention. Risk of serious damage to the lungs (by aspiration).

Ingestion

Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Drink plenty of water. Get medical attention. If possible drink milk afterwards. Call a physician or poison control center immediately. If vomiting occurs naturally, have victim lean forward.

Most important symptoms and effects

Difficulty in breathing. Inhalation of high vapor concentrations may cause symptoms like headache, dizziness, tiredness, nausea and vomiting
