SECTION 4. FIRST AID MEASURES

Eye Contact

Immediate medical attention is required.

Most important symptoms and effects

Causes burns by all exposure routes. Difficulty in breathing. Product is a corrosive material. Use of gastric lavage or emesis is contraindicated.
